"YES" We've observed no behaviors with this animal that cause us to believe it will be unsafe with small children.

"NO" Based on behaviors we've observed or learned about from a former owner, we believe this animal is not a good match for a family with small children.

"UNKNOWN" We've not observed problematic behaviors, but will help you understand possible challenges.

ADOPTER EXPERIENCE?

"1ST TIME" This is a animal that can be adopted by a first-time pet owner.

"SOME EXP" An adopter with some previous experience would be ideal for this animal.

"VERY EXP" We are looking to place this pet with an adopter very experienced with this breed or with managing complicated behaviors.

All information is based upon our limited experience with this animal in a shelter environment, usually for a short time and does not guarantee long term behavior in a home environment. We suggest that families have their child/ren meet the animal prior to adopting to see the animal's and child's reaction. All interactions, even those at home should be supervised by adults. 
